LAINGSBURG CITY COUNCIL PROCEEDINGS August 7, 2017

Mayor Culpepper called the meeting to order at 7:00 p.m. in the City Hall Council Chambers.

Councilman Fredline led the Pledge of Allegiance.

Present: Marcie Nickols, David Rhodabeck, Larry C. Sparkes, Brian Fredline, Larry L. Sparkes and Micheal Culpepper. Members absent: Alan Ducastel

Public Comment – Commissioner Bartz gave a County update.

Moved by Fredline, seconded by Rhodabeck to approve the minutes of July 10, 2017, as corrected. Motion carried.

Moved by L.L. Sparkes, seconded by Fredline to approve the Treasurer's Report subject to audit. Roll call vote: Yeas: L.L. Sparkes, Fredline, Rhodabeck, L.C. Sparkes, Nickols and Culpepper. Nays: None. Absent: Ducastel. Motion carried.

Moved by L.C. Sparkes, seconded by Fredline to open the public hearing on Traffic Control Orders to establish no parking areas along Prospect Street from Crum to Elm in front of the Elementary School and along the 100-200 Block of Railroad Street. All in favor, Motion carried.

Public Hearing – No Public Comment. The Chief of Police explained that the school had been contacted. He gave an overview of the need to establish the no parking areas.

Moved by L.C. Sparkes, seconded by Fredline to close the public hearing on Traffic Control Orders to establish no parking areas along Prospect Street from Crum to Elm in front of the Elementary School and along the 100-200 Block of Railroad Street. All in favor, Motion carried.

Moved by Rhodabeck, seconded by L.C. Sparkes to approve Resolution number 1709 adopting Traffic Control Order Number 231, No Parking Zone: Prospect Street from Crum to Elm in front of the Laingsburg Elementary School. Roll call vote: Yeas: L.L. Sparkes, Fredline, Rhodabeck, L. C. Sparkes, Nickols and Culpepper. Nays: None. Absent: Ducastel. Motion carried.

Moved by Rhodabeck, seconded by L.C. Sparkes to approve Resolution number 1710 adopting Traffic Control Order Number 232, No Parking Zone: 100-200 Block on Railroad Street. Roll call vote: Yeas: L.L. Sparkes, Fredline, Rhodabeck, L.C. Sparkes, Nickols and Culpepper. Nays: None. Absent: Ducastel. Motion carried.

Presentation from SATA – members from the public spoke regarding their need for the services provided through SATA. MaLissa Schutt, SATA Representative was not present at this time to present information regarding the SATA Programs and the cost.

Moved by L.C. Sparkes, supported by Rhodabeck to put SATA on the September Agenda and ask for a representative of SATA to attend our September meeting to answer questions, explain the services and the cost of participating. All in favor, motion carried.

Moved by Rhodabeck supported by L.L. Sparkes to approve seeking bids to install sidewalk on Third North Street from West Street to Crum Street. All in favor, motion carried.

Moved by Rhodabeck supported by L.C. Sparkes to approve the Proposal to replace valves at the Waste Water Treatment facility. Roll call vote: Yeas: L.L. Sparkes, Fredline, Rhodabeck, L. C. Sparkes, Nickols, and Culpepper. Nays: None. Absent: Ducastel. Motion carried.

Moved by L.L. Sparkes, seconded by Fredline to accept the LSW Emergency Services Authority 2018-19 Budget, as presented. Motion carried.

Moved by L.C. Sparkes, seconded by Nickols to pay the bills in the amount of \$156,887.63, using General Fund check numbers 39513 - 39564 and electronic payments of \$9,228.80 for July. Roll call vote: Yeas: L.L. Sparkes, Fredline, Rhodabeck, L. C. Sparkes, Nickols and Culpepper. Nays: None. Absent: Ducastel. Motion carried.

Malissa Schutt the representative from SATA arrived at 7:39p.m. The Mayor offered her the opportunity to present the information she was scheduled to provide earlier in the Agenda.

Moved by Fredline, supported by L.C. Sparkes to participate with SATA for the coverage year beginning October 1, 2017, and ending September 30, 2018. Roll call vote: Yeas: Fredline, Rhodabeck, L.C. Sparkes & Nickols. Nays: L.L. Sparkes & Culpepper. Absent: Ducastel. Motion carried.

Dave Hartman inquired as to the City plans for the City owned property that contains two vacant buildings on Laing Street. Mr. Hartman will provide a proposal to the City's Finance Committee prior to the next regular City Council meeting.

Moved by Fredline, seconded by L.C. Sparkes to adjourn. The motion was unanimous and the meeting adjourned at 8:25 p.m.
