The regular meeting of the Laingsburg Downtown Development Authority was called to order at 6:05 p.m. in the Laingsburg City Hall Council Chambers.

Moved by Geasler, supported by Thomas to approve the minutes of the March 27, 2017 meeting. All in favor, motion carried.

Moved by Geasler supported by Thomas to approve the treasurer's report for March 2017. All in favor, motion carried.

There were two competitive bids received and reviewed for the downtown sidewalk project.

Moved by Lancour, supported by Thomas to approve the Extreme Mason bid of \$47,363 pending clarification regarding the replacement of steps and ramps. Roll call vote: yeas: Brink, Thomas, Nays: Culpepper, Abstain: Lancour, Geasler, Absent: Hunt, Darr, Shinsky. Motion carried.

Christopher Germain was present representing the MEDC – Redevelopment Ready Communities (RRC) Program. The City is in the process of trying to become a certified RRC. The DDA was asked to formally review their Downtown Improvement Plan.
