Ducastel thought it had already been decided last month to keep the ordinance authorizing two micro business licenses. Judd and Rhodabeck mentioned that they were not clear on what the vote meant last month. They have since asked questions and asked to have the Resolution put back on the agenda. The Planning Commission and the DDA both made recommendations that the City Council prohibit the Micro Retail Business and any operations that would allow the growing of Marihuana. The LBCA connected with the businesses and nineteen businesses signed a letter requesting that the City Council limit the number of retail marihuana licenses as well as voicing concerns regarding businesses that would grow marihuana.
