### MORATORIUM ON COMMERCIAL, MEDICAL AND RECREATIONAL USE, MARIHUANA FACILTIES LICENSING

Minutes of a regular meeting of the City Council of the City of Laingsburg, County of Shiawassee, State of Michigan, held on the 9<sup>th</sup> day of January, 2023 at 7:00pm Eastern Daylight Time.

The following preamble and resolution were offered by Beavers and supported by Judd:

A RESOLUTION OF THE CITY COUNCIL OF Laingsburg, amending Resolution 2115 a moratorium to stop accepting and reviewing any new medical or recreational marihuana establishment license, special land use permits & site plan review applications related to ORDINANCE 01-2019 and 02-2019 of the City of Laingsburg Code of Ordinances & the City of Laingsburg Zoning Ordinance Article 8, Section 837, Marihuana Retailer

WHEREAS, the City Council has determined that a moratorium is necessary to get the newly elected board members educated on the current Marihuana Market and how city ordinances will be affected as a result. No new licenses for additional medical or recreational use establishments will be issued until the City has completed a full review of its existing ordinances, proposed, changes, and any additional considerations of the public.


NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF Laingsburg, MICHIGAN:

The City of Laingsburg will establish a moratorium on the issuance of any new medical and/or recreational use establishment licenses, special land use permits & site plan review applications. The moratorium will be lifted by the City by no later than December 31, 2023, unless the issue is not resolved and requires further extension.


